- Bidding will be conducted through open competitive bidding procedures using non- discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organization of a country the laws or regulations of which grant similar rights and privileges to Filipino citizens, pursuant to RA 5183.

- 4. Prospective Bidders may obtain further information from the Municipal Government of Bangar, La Union and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon (Monday to Thursday only).
- 5. A Complete set of Bidding Documents may be acquired by interested bidders on November 19, 2021 to December 9, 2021 (Monday to Thursday) from the address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount opposite the title of Project to be bid. The Procurement Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile or through electronic means.
