2. The Municipal Government of Bangar, La Union now invites bids for the above Procurement Projects. Delivery of the Goods is required **Thirty (30) Calendar Days** for all projects. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non- discretionary pass/fail criterion as specified in the updated 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organization of a country the laws or regulations of which grant similar rights and privileges to Filipino citizens, pursuant to RA 5183.

4. Prospective Bidders may obtain further information from the Municipal Government of Bangar, La Union and inspect the Bidding Documents at the address given below from **8:00 in the morning to 5:00 in the afternoon (Monday to Friday except Holidays)**.
5. A Complete set of Bidding Documents may be acquired by interested bidders on **April 15, 2024 to May 6, 2024 from 8:00 in the morning to 5:00 in the afternoon (Monday to Friday except Holidays)** from the address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount opposite the title of Project to be bid. The Procurement Entity shall allow the bidder to present its proof of payment for the fees presented in person, by facsimile or through electronic means.

9. Bid opening shall be on **May 6, 2024 at 2:00 o'clock in the afternoon at the Municipal Conference Hall, Bangar, La Union**. Bids will be opened in the presence of bidders' representatives who choose to attend at the activity.

The Municipal Government of Bangar, La Union reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35 and 41 of the updated 2016 Revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
